"World Commission on Dams" [WCD] Final Report

With the November 2000 release of the report of the "World Commission on Dams" (WCD), human rights and development organizations are demanding that the funders of the "international dam industry", including the World Bank, Inter-American Development Bank and export credit agencies, halt all support for dams until the WCD's recommendations are implemented. We are also demanding reparations for damage and loss of life caused by dams in the past.

The WCD is an independent body, sponsored by the World Bank, to review the performance of large dams in the past, and make recommendations for future planning of water and energy projects. The Chixoy Dam in Guatemala was one of the dam projects they looked closely at.

FINDINGS

The WCD's report provides ample evidence that large dams have failed to produce as much electricity, provide as much water, or control as much flood damage as their backers claim. In addition, these massive projects regularly suffer huge cost overruns and time delays. Furthermore, the report shows that:

• . . . large dams have forced 40-80 million people from their homes and lands, with impacts including extreme economic hardship, community disintegration, and an increase in mental and physical health problems. Indigenous, tribal, and peasant communities have been

- particularly hard hit. People living downstream of dams have also suffered from increased disease and the loss of natural resources upon which their livelihoods depended;
- . . . large dams have caused great environmental damage, including the extinction of many fish and other aquatic species, huge losses of forest, wetland and farmland; and
- . . . the benefits of large dams have largely gone to the already well-off while poorer sectors of society have borne the costs.

RECOMMENDATIONS

Based on these findings, the WCD recommends that:

- . . . no dam should be built without the informed agreement of the affected people;
- . . . comprehensive and participatory assessments of the needs to be met, and alternatives for meeting these needs should be developed before proceeding with any new project;
- . . . priority should be given to maximizing the efficiency of existing water and energy systems before building any new projects;
- . . . periodic participatory reviews should be done for existing dams to assess such issues as dam safety, and possible decommissioning;
- . . . mechanisms should be developed to provide reparations for those who are suffering the impacts of dams, and to restore damaged ecosystems.

NGO Call for Action

NGOs monitoring the WCD have prepared this call to public financial institutions. CALL TO FINANCIAL INSTITUTIONS

Given the role of financial institutions in funding large dams and in the WCD process, we call on all public financial institutions, including the World Bank, the regional development banks, the export credit agencies and bilateral aid agencies, to take the following actions:

- (1) All public financial institutions should immediately and comprehensively adopt the recommendations of the World Commission on Dams, and should integrate them into their relevant policies, in particular those on water and energy development, environmental impact assessment, resettlement, and public participation.
- (2) All public financial institutions should immediately establish independent, transparent and participatory reviews of all their planned and ongoing dam projects. While such reviews are taking place, project preparation and construction should be halted. Such reviews should establish whether the respective dams comply, as a minimum, with the recommendations of the WCD. If they do not, projects should be modified accordingly or stopped altogether.

- (3) All institutions which share in the responsibility for the unresolved negative impacts of dams should immediately initiate a process to establish and fund mechanisms to provide reparations to affected communities that have suffered social, cultural and economic harm as a result of dam projects.
- (4) All public financial institutions should place a moratorium on funding the planning or construction of new dams until they can demonstrate that they have complied with the above measures.

CHIXOY DAM REPARATIONS CAMPAIGN

Based on WCD findings in general, and on the 3rd point of the NGO call to all institutions involved with and profiting from the "international dam industry", please write letters to the World Bank and the Inter-American Development Bank, demanding that they establish an independent commission that will investigate and determine the quantity and nature of the reparations that the WB and the IDB owe the survivors of the Chixoy Dam/Rio Negro Massacres.
