## TRADES UNIONISTS CALL FOR PROTECTION FOR BISHOP

TRADE UNION activists have called upon the government of Guatemala to protect a Roman Catholic bishop from assassination at the hands of right-wing death squads.

Mgr Álvaro Ramazzini, the Bishop of San Marcos, has been warned that he will be killed unless he withdraws his support for landless peasants (campesinos) and Indians who have protested the issuance of mining permits to a Canadian multinational corporation [RA note: this company is Goldcorp Inc.].

On March 31 a nun was stopped while driving her car through the town of San Marcos and given a note to deliver to the bishop, warning him of the consequences of his actions

Bishop Ramazzini is president of the Roman Catholic Bishops Conference of Guatemala and the Church's representative to the "High Level Commission" formed to regulate the exploitation of the region's natural resources.

He has drawn the ire of landowners for backing the campesinos and insisting upon strict environmental safeguards and equitable labour practice to prevent the despoliation of the forests and farmland of the region as well as the exploitation of its people.

A longtime advocate for the poor in the Central American country, in January 2005, Guatemalan President Óscar Berger blamed Bishop Ramazzini for riots in San Marcos after police shot a campesino during antigovernment demonstrations. President Berger said the bishop was an "authentic leader" who should have controlled the protestors.

Along with other bishops he also played a pivotal role in the 1996 Peace Accords that ended Guatemala's 36year-long civil insurrection that left an estimated 150,000 dead [RA note: over 250,000].

Bishop Ramazzini co-authored a 1998 report detailing government human rights abuses. Two days after the report was released the principal author of the report, the Archbishop of Guatemala Juan Gerardi, was bludgeoned to death.

Bishop Ramazzini was a witness in the Gerardi murder case, which saw three army officers and a priest convicted of the archbishop's murder. In 2005 he testified before the United States Congress on human rights violations in Guatemala and urged the rejection of a Free Trade Agreement between the US and Guatemala saying it would serve only to exploit the campesinos, who make up 95 per cent of the population.

On April 1, 2008 the International Trade Unions Confederation (ITUC) wrote to current Guatemalan President Álvaro Colom demanding that "the necessary measures be taken to guarantee the safety and physical integrity of Monsignor Álvaro Ramazzini and to ensure that such threats cannot be carried out in a Guatemala where all citizens can freely enjoy their fundamental rights."

The ITUC has also urged the UN's International Labour Organisation (ILO) to place Guatemala's human rights record before the international body, urging it to bring pressure upon the government to institute economic and land reforms in the Central American republic.
