Community Leaders from Honduras and Guatemala attend Goldcorp's shareholder meeting, denounce the environmental, health and human rights harms caused by mine

Leaders from communities directly impacted by Goldcorp's open pit cyanide leaching operations in Central America will attend the annual general meeting of Goldcorp on May 20. Carlos Amador from Honduras and Fausto Valiente from Guatemala traveled to Toronto this week denouncing Goldcorp for the environmental, social, health and human rights harms in both regions where the company is operating.

"A real benefit of speaking tours like this one is that they raise awareness about both the harms of mining and the way in which all of us as Canadians are implicated in this exploitative industry", said Grahame Russell, codirector of Rights Action, a US and Canadian NGO based in Guatemala City, who has been working directly with grassroots organizations in the affected communities, and in building solidarity and activism in the 'global north.' "This is our problem - Who benefits? Who pays the price? These are the questions that all of us need to ask."

The Canada Pension Plan, many unions pension plans and even mutual funds marketed as "ethical" are major investors in Goldcorp. Recently, Jantzi Research decided to remove Goldcorp from their "Jantzi Social Index," which rates corporations within each industry sector, a development viewed as a positive result of campaigns directed at educating Canadians about the real impact of mining. "The problem is that mining is only being reported on the business pages" Russell continued, "the environmental devastation, health problems, social harms and human rights violations are serious issues that Canadians need to know about."

"Goldcorp mines have caused numerous health and environmental harms to the residents of the Siria Valley," says Carlos Amador from the Siria Valley Environmental Defense Committee. "Now, we are traveling to other communities to warn them about how these companies lie to communities and what the true effects of open-pit mining are regarding health and the environment." The communities of the Siria Valley, while maintaining their longstanding opposition to Goldcorp's San Martin mine, are now also demanding justice and reparations in order to deal with this health crisis, provide long-term care for the victims of heavy metal poisoning, and recuperate the environment.

"Goldcorp is continuing to mine and to seek mining licenses in areas where local indigenous communities have clearly voiced their overwhelming opposition to the mining projects in community consultations." says Fausto Valiente. In accordance with ILO convention 169 on indigenous rights, the Constitution of Guatemala and the municipal code, on June 18, 2005, all thirteen communities in the municipality Sipakapa carried out consultations to determine whether or not the population wanted mining activity in their territory: 11 villages voted against all mining, one voted in favour, and one abstained. Eighteen municipalities in Guatemala's indigenous highlands - many of which are covered by Goldcorp mining licenses - have followed suit with their own community consultations, in which a consistent 98% of the population rejects all mining.

The Honduran and Guatemalan delegates will publicly denounce Goldcorp's operations on their lands and ask shareholders to demand that the company immediately suspend all mining operations in their countries.
