#### **POWER IN NUMBERS:**

COMMUNITY CONSULTATIONS IN SAN MIGUEL IXTAHUACAN SAYING NO TO MINING

Legally constituted community consultations are being organized and carried out in towns and villages across the municipality of San Miguel Ixtahuacan (SMI), Guatemala, as a way for mining-affected, Mayan-Mam communities to meet, discuss and determine if they are opposed to, or in favour of Goldcorp's "Marlin Mine" that has been operating an expanding open-pit, cyanide heap-leach mine in this region for four years. Beginning with the Sipakapa municipal consultation in 2005, that said no to Goldcorp's mine, there have been some 30 municipal consultations in Guatemala, mainly in the indigenous highlands. Every one has said no to mining, and to other large-scale "development" projects that are imposed undemocratically and proceed with no community knowledge or permission.

All previous consultations have taken place 'after' the government has illegitimately granted mining licenses, but 'before' mining – or other large-scale "development" projects – get under way.

In San Miguel Ixtahuacan, villagers are carrying out their consultations, on a community-to-community basis, where Goldcorp is already mining. The stakes and tensions are high.

April 14th: El Colmito, a community in SMI, held a community consultation and voted 'no' to mining on their territory. May 2nd: the community of Eden held a consultation and voted 'no' to mining on their territory as well. Eden is the 11th community, so far, in SMI to carry out a consultation about Goldcorp's mining operations in the region.

Prior to initiating mining at the "Marlin Mine" site in 2005, Goldcorp Inc., the governments of Guatemala and Canada, and the World Bank (that invested \$45,000,000 in the "Marlin Mine") did not consult with or get the approval of the affected indigenous communities. So doing, they violated the 1996 Peace Accords and Convenant 169 of the International Labour Organization that require the State, prior to any large-scale "development" project or investment, to enable free, prior and informed consent of the populations to be affected by the project or investment.

Community consultations in SMI are a way for the local Mayan-Mam populations to take democracy into their own hands and reclaim their legally enshrined right to decide the future of their children, to decide what kind of development they want on their land and whether Goldcorp can continue mining operations on indigenous territory in SMI.
