## CHOC versus HUDBAY Update – February 13, 2011

# HUDBAY SEEKS TO HAVE LAWSUIT, REGARDING THE KILLING OF ADOLFO ICH, HEARD IN GUATEMALA'S TROUBLED LEGAL SYSTEM THAT IS ALMOST COMPLETELY CHARACTERIZED BY IMPUNITY

On December 1, 2010, the Klippensteins law firm in Toronto announced what will hopefully be a precedent-establishing legal case in Canada: Choc versus HudBay.

On September 27, 2009, Mr. Ich, a respected Mayan-Qeqchi community leader, school teacher and father, was hacked and shot to death by security forces employed by HudBay Minerals at its "Fenix" mine, in an unprovoked and targeted attack near the town of El Estor, Guatemala.

Now, HudBay Minerals has responded to the lawsuit by filing papers that ask an Ontario court to send the case to be heard in Guatemala, despite the widely-known and severe problems with Guatemala's legal system that make a fair and impartial hearing impossible.

#### **GUATEMALA COURTS & IMPUNITY**

HudBay's request to have the case heard in Guatemala appears to be an attempt to avoid liability and to prevent an appropriate legal inquiry into the truth of what happened to Adolfo Ich and who is responsible.

HudBay is assuredly aware that if it is successful in this motion, there will be no justice in the murder of Adolfo Ich.

The Guatemalan criminal investigation into Adolfo's death has stalled, predictably. Better said, this criminal investigation (like the vast majority filed in Guatemala courts) never really proceeded. In December 2009, as a result of an initial investigation, an arrest warrant was issued for Mynor Ronaldo Padilla Gonzáles, the head of security for HudBay's "Fenix" project. Eyewitnesses say that Mr. Padilla shot Mr. Ich in the head at close range. Despite this arrest warrant, Mr. Padilla was repeatedly seen at the Fenix Project in 2010, and has still not been apprehended.

This is not surprising. Human Rights Watch calls Guatemala's law enforcement institutions "weak and corrupt". The UN-sponsored International Commission Against Impunity (CICIG) in Guatemala has said that "the judicial system in Guatemala has almost collapsed". The Inter-American Commission on Human Rights has said that the Guatemalan State lacks the capacity to provide "an adequate justice administration system".

And, the United Nations Special Rapporteur on Extrajudicial Executions stated that "Guatemala is a good place to commit a murder, because you will almost certainly get away with it".

#### **FUNDS NEEDED**

Rights Action asks for financial support to ensure that this case advances in the Canadian courts and that justice is done for the brutal, unprovoked killing of Adolfo Ich.
