Dear friends.

May 2013 be the year that the Inter-American Development Bank (IDB) and World Bank (WB) finally do the right thing and take the necessary steps to ensure that reparations are finally paid to the surviving victims of the ill-conceived and violently implemented Chixoy hydro-electric dam, 1975-1985.

While it is the State of Guatemala that is obliged to pay for the Reparations Plan, as agreed upon in 2010, this is because of the impunity with which your banks operate, and not due to any notion of justice or fairness. The Chixoy Dam project was a huge "development" project of the IDB and the WB in partnership with successive Guatemalan military regimes during the worst years of Guatemala's State repression and genocide, 1975-1985.

Payment of full reparations must be ensured by both banks and the government of Guatemala.

Like many people and organizations, I am dismayed by the lack of response from the WB, the IDB and the government of Guatemala. In response to a previous communication, we received a one-paragraph letter (November 2, 2011) from Pamela Cox, vice-president of Latin American and the Caribbean Regional Office of the World Bank, saying:

"we [the World Bank] share your desire for a swift resolution of this process and a satisfactory outcome for the affected Chixoy communities."

This is a shockingly insensitive response.

31 years have elapsed since the repression (including wholescale massacres) and forced evictions caused by the Chixoy Dam.

8 years have passed since the government of Guatemala finally sat down with the victims to negotiate a reparation and development plan.

3 years have passed since the government of Guatemala accepted its responsibility for the harms and destruction and agreed to pay for a reparation and development plan for the harmed communities and people.
