## Community Blocks Inter-American Highway To Oppose Mining

A demonstration is blocking Kilometer 170 of the Inter-American Highway, in Santa Catarina Ixtahuacán, Sololá, to protest against [Goldcorp Inc's] mining activities in Sipicapa, San Marcos. For this same reason, a demonstration is also blocking Kilometer 242 of the highway to Pajapita, San Marcos.

GUATEMALA CITY – Although the police is in the area trying to negotiate with protesters, demonstrators have indicated their decision to remain in the area throughout the day. The granting of new licenses for [Goldcorp's] exploration in San Carlos Sija has caused discontent in the population, which supports the protest, fearing that a civil war will resurge if the opinion of the communities is not taken into account.

Until this moment, some 200 vehicles are trapped in both directions of the highway. Those traveling on buses opted to transfer buses, and had to walk at least three kilometers to get to the other side of the blocked area.

A week ago, community members from several hamlets retained 35 workers from the mine to demand that company authorities buy them a water source so they can have access to that vital liquid, arguing that contamination is affecting their capacity to consume that resource.

## Members Of San Marcos Protest Against [Goldcorp's] Marlin Mine For The Lack Of Water

SAN MARCOS - Esperanza López, departmental delegate of the Presidential Commission on Human Rights, COPREDEH, informed that protesters had retained a group of mining workers, who they seek to exchange for a water project, because they affirm that ever since the mining company came, their sources of water dried up.

According to members of the community, representatives of [Goldcorp's] Marlin mine promised to bring them water by other means, and they did not fulfill their commitment. Basilio Bámaca, who lives in the area, said that the sources of water dried up, and what used to be large streams don't exist anymore. "The mining company wanted to put a band-aid on a gaping wound and they connected us to a water service that didn't function. It only lasted fifteen days and now we have none of that vital liquid (water). We want government authorities to help us to resolve this problem because this issue is very serious," he added.

#### Community Is Not Retaining Anyone

"We are not retaining anyone, we are just warning the miners that from now on we are going to take action, since the Mine is to blame for the fact that we have no water now. The natural springs have dried up and that is not viable" affirmed Bámaca.

Josué Navarro, from the Peace and Ecology Commission, said that because the neighbors denounced this case, the report on water contamination was presented, which is being meticulously evaluated due to the high amounts of water that [Goldcorp's] Marlin mine extracts through mechanized wells, which made the natural springs dry up.

Representatives of the Marlin mine told the community that they will aid them providing them with drinking water. "We have scheduled a project to provide drinking water and very shortly we will fulfill our promise" they affirmed.
