U.S. Senate Considering Withholding Funds from World Bank (WB) and Inter-American Development Bank (IDB), Until Chixoy Dam Reparations Plan Paid for and Implemented in Guatemala

From 1975-1985, the World Bank and Inter-American Development Bank partnered with the repressive and genocidal regimes of General Lucas Garcia, 1978-1982, and General Rios Montt, 1982-1983, and invested close to one billion dollars in the Chixoy dam "development" project. Over 440 Mayan villagers were massacred; thousands more were illegally and forcibly evicted from land and home. The survivors have been suffering in poverty and abandonment ever since.

Dear Sirs and other WB and IDB employees,

May 2014 be the year when your Banks ensure that reparations are finally paid to the surviving Mayan victims of your ill-conceived and violently implemented Chixoy hydroelectric dam in Guatemala, 1975-1985.

In 2010, the President of Guatemala formally accepted government responsibility to provide \$150,000,000 for the Reparations Plan for thousands of victims of the Chixoy dam project. The IDB and WB officially observed and endorsed the negotiation process and Reparations Plan.

Since 2010, the government of Guatemala has refused to release the \$150,000,000, and the Chixoy dam surviving victims continue to live in chronic conditions of poverty, abandonment and on-going trauma.

Rights Action is supporting efforts in the U.S. Senate to withhold any new funds to the WB and the IDB, until the Reparations Plan has been funded and community members begin to implement the reparations and restoration projects and programs included in the Plan.

Chixoy Dam

- Between 1975-1985, the WB and IDB partnered directly with the repressive and genocidal regimes of General Lucas Garcia, 1978-1982, and General Rios Montt, 1982-1983, and invested close to one billion dollars in the Chixoy dam "development" project
- Over 440 Mayan Achi villagers from the remote community of Rio Negro were massacred by Guatemalan soldiers and police, and private security guards directly employed by your project, as part of an effort to 'evict' them, to help make way for the filling of the dam flood basin
- Thousands of other Mayan people, from some 32 villagers, were forced to leave their home communities. None received anything close to proper compensation for all that was taken from them including land, animals, access to water, trees, plants, homes, personal property, etc. 25 Mayan villages upstream from the dam wall, and 7 more downstream suffered various degrees of devastation and illegal eviction
- Both your banks profited financially from your investments in this "development" project

Institutional Indifference

Both your banks continue to publicly state that you complied with all terms of the Chixoy Dam project. This is false. In response to a previous communication to the WB (and the IDB), Rights Action received a one-paragraph letter (November 2, 2011) from Pamela Cox, vice-president of Latin American and the Caribbean Regional Office of the World Bank, saying: "we [the World Bank] share your desire for a swift resolution of this process and a satisfactory outcome for the affected Chixoy communities." "Swift"? "Satisfactory"?

What To Do / Who To Contact?

Your banks know what you must do, with respect to the government of Guatemala, and you know who you must deal with in Guatemala.
