Peaceful, Courageous Resistance at "La Puya"

Since early 2012, Rights Action has – with your support - been providing funds to the communities of San Jose del Golfo and San Pedro Ayumpuc that are peacefully resisting the illegal, harmful entry of the US-based Kappes, Cassiday & Associates ("KCA" - <u>http://www.kcareno.com</u>) mining company onto their lands and territories, protecting their local watersheds and environment, promoting community controlled development projects.

The Canadian company Radius Gold Inc. (<u>http://www.radiusgold.com/</u>) first tried to forcibly operate this "Tambor" mine. During Radius Gold's ownership, an assassination attempt was carried out against Yoli Oqueli, a community member, on June 13, 2012. Barely escaping death, she remains a strong member of the peaceful resistance, with a bullet lodged close to her spine.

Never being held to account, neither in Guatemala nor in Canada, for the assassination attempt against Yoli, Radius sold most of its interests to KCA in late 2012. However, if ever KCA operates this harmful, unwanted mine, KCA will make quarterly payments to Radius totaling \$10m. "Additional royalty payments will be made based on the future price of gold and the number of ounces produced from the property", Radius informs its investors. Radius adds that it remains "optimistic that commercial production will be achieved at Tambor and the company will be reimbursed for the investment it has made in the region since discovering gold at Tambor in the year 2000."
