The Petition

"In 2007 eleven Mayan Q'eqchi' women were raped. In 2009 a Mayan Q'eqchi' community leader was hacked with a machete and shot to death, and a young father was shot and to this day remains paralyzed.

"These events are alleged to have been perpetrated directly and/or vicariously by Hubday Minerals, a Canadian Mining company. As a result of these human rights abuses, Hubday is facing three lawsuits in Ontario.

"Yet, in 2008 Hubday made a donation to the Canadian Museum for Human Rights and in return Hubday is now recognized as a "friend of the museum" and has a special plaque in the museum commemorating it.

"How can it be a museum dedicated to human rights celebrates a corporation facing such allegations? It is called "The Canadian Museum for Human Rights", not "The Canadian Museum for Human Rights Abusers". This cannot stand.

"Join with me to lobby the Museum to remove Hudbay's special plaque in the Museum and their recognition as a "friend" of the museum. The integrity of the Museum for Human Rights must be maintained and this partnership infringes everything the Museum is supposed to represent."
