The never-ending criminal trial continues against Mynor Padilla, former head of security for Hudbay Minerals (CGN-Guatemalan Nickel Company), for murder of Adolfo Ich, shootingparalyzing of German Chub, and wounding of other campesinos in El Estor, Izabal.

It is rumoured that the judge will give her sentence some time this fall, ... but there remains also a fear that the trial will just drag on and on, which is in part a tactic to keep on wearing down Angelica Choc and the other victims, witnesses of the mining-related repression who are spear-heading the efforts for justice, along with lawyers from the Attorney General and CICIG.

How Can Angelica Choc and German Chub Get Justice?

In May 2016, the judge in the Adolfo Ich murder trial ordered a "security protection detail" for Mynor Padilla (!), former head of security for Hudbay Minerals, already in jail while on trial for the mining related murder of Adolfo Ich and shooting-paralyzing of German Chub in September 2009.

Hearing: August 23-24, Sentencing Court, in Puerto Barrios

- The "reconstruction of the crime scene" began July 6 and ended July 28
- It has been one year and three months since the trial began!
- It has been almost 7 years since the September 27, 2009, mining related repression occurred

We insist that the search for justice in Guatemala is not only lagging and incomplete, but highly onerous because of the high economic cost for the victims and injured parties who demand justice. The justice system is unreachable for the great majority of Guatemalans, especially for the Mayan people who have been affected by these crimes and other human rights violations committed by transnational mining companies, with the sole purpose of dispossessing people from their land.

This long waiting period has resulted in frustration, dispersion, confusion, and distraction with respect to the crimes being tried, of which many people in the community of El Estor were victims; yet despite this, strong statements made by the witnesses and the steadfastness in which they have related the events from September 27, 2009, have generated certainty about what occurred and who is responsible.

There is clear evidence to obtain a guilty verdict, so that the crimes committed by Hudbay Minerals / CGN in El Estor on September 27, 2009 against Professor Adolfo Ich, German Chub and other campesinos from the community of Las Nubes do not remain in impunity.

The conclusion of the trial and issuing of the sentence by the judge of the Sentencing Court of Puerto Barrios draws near.

We call on the Human Rights Ombudsman, CODIRSA, the United Nations' High Commission in Guatemala, and international solidarity organizations who defend human rights and promote justice, to pronounce before the judicial system, the Supreme Court of Justice, and other judicial bodies that the trial be considered a high-impact case and no longer be held behind closed doors.

To social and campesino organizations, to civil society, and communities of El Estor, Izabal, we ask for your continued solidarity and accompaniment of the struggle for justice being carried out by the Ich Choc family, German Chub, and the campesinos from the community of Las Nubes.

For the right to live, the right to our land, we demand justice. Communities in resistance and struggle for the land, El Estor, Izabal August 22, 2016
