Dear Friends, in June 2017, I was at the Canadian Museum for Human Rights (CMHR) for the opening of the Points of View exhibition, where my photo "Landscapes of Resistance" is featured, and up for a People's Choice Award.

The museum is fraught with contradictions. Built on top of an improperly excavated Ojibway archeological site and made possible by donors like HudBay Minerals.... the list goes on. While there are excellent exhibits and tremendous stories inside, there are of course other stories that are not told too.

Below, you will find a press release. I ask you to going online and vote for my photo. I have committed to donating all the winnings towards the 11 women's legal defense fund through Rights Action. Amnesty International, Mining Watch, and Rights Action are helping to spread the word.

After I submitted my photo of Irma Yolanda, I had to fight with the museum staff to leave Hudbay Minerals' name in the description of the image. The museum had wanted to delete reference to Hudbay. In 2008, Hudbay donated \$1 million to the Museum.

Outside the Points of View exhibition is the donor wall, and it includes Hudbay's name and a 3 minute video on how the company puts human rights first in everything they do. The photograph inside the exhibition points to the company's negligence and links their actions to the sexual violations against the women.

Featured amongst the 70 images selected to highlight Canada and human rights is an environmental portrait of Irma Yolanda Choc Cac, an Indigenous Q'eqchi' Maya woman from the remote community of Lote Ocho in eastern Guatemala.

Choc Cac is one of eleven Indigenous women currently suing Canadian mining company HudBay Minerals Inc. (Toronto) for alleged sexual violations during a forced eviction from her community's ancestral lands in 2007. This case is one of three precedent setting lawsuits in Ontario courts; the first of their kind attempting to hold a Canadian mining company accountable for negligence and carelessness abroad.

The photograph, titled Landscapes of Resistance, features Choc Cac standing amongst the charred remains of her home; burned to the ground by company private security forces, Guatemalan police, and military when community members refused to leave.

Doctoral candidate Alexandra Pedersen (Queen's University) took this photograph while revisiting the community of Lote Ocho as a member of an educational delegation co-led by Dr. Catherine Nolin (University of Northern British Columbia) and Grahame Russell (Rights Action).

Choc Cac, as well as several other women involved in the lawsuit, shared their testimonies with delegates and requested that their experiences of extreme violence and injustice involving HudBay Minerals be shared widely with Canadians.
