89 bodies dug up by Aura Minerals, Canadian company in Honduras, to get at more gold

Even as the Honduran military and police have killed over 40 people protesting the stolen elections of November 27, 2017, Aura Minerals and MINOSA (its Honduran subsidiary) have dug up at least 89 cadavers, pressuring and paying mostly impoverished families for the "right" to move their dead.



On a number of occasions, Aura Minerals/MINOSA have dug up the "wrong bodies", those of families who - despite harassment and repression by soldiers, police and company security guards - oppose the desecration and destruction of their 200 year old cemetery and removal of their dead.

On September 5, 2017, Aura Minerals/MINOSA - supported by Canadian authorities and investors and the Honduran government and military - began the grotesque, depraved process of trying to clear out this sacred place. Watch film clip: https://www.youtube.com/watch?v=sQWtlh8XloQ

The attempted destruction of the Azacualpa cemetery comes after years of operation of this open-pit, cyanide-leaching gold mine that has caused health harms, deforestation, air pollution, water pollution and depletion, destruction of the local economy, repression against and 'criminalization' of community members, many with the Azacualpa Environmental Committee, who document and protest the harms and violations.



Pending destruction of the village of Azacualpa?

Not only do most community members want the destruction of their cemetery to stop – there are hundreds of loved ones buried there - but they know that Aura Minerals wants not only the gold under the cemetery, but also on the other side of the cemetery, up the mountain ridge, including – a few kilometers away – the village of Azaculapa.

Outcry?

How grotesque and harmful does Canadian-backed mining have to be, before Canadian politicians, media, investors and the industry say enough? Until the people of the home country of the mining companies – Canada, in this case – hold their companies, investors and governments legally and politically accountable for environmental harms, human rights violations and repression caused by mining, these abuses – including the desecration of the dead - will continue.
