### To Minister Freeland,

On Tuesday April 10, 2018, Karen Spring, Jen Moore, and myself, Janet Spring, attended a meeting with representatives from Global Affairs Canada (GAC). We travelled to Ottawa from Elmvale Ontario to specifically address the illegal incarceration of our family member Edwin Espinal and other political prisoners who are detained in horrific conditions in maximum-security prisons in Honduras. They were arrested because of speaking and peacefully demonstrating their opposition to the repressive situation surrounding the fraudulent election process of the November 2017 election of Juan Orlando Hernandez.

In attendance and leading the meeting was Ioanna Sahas Martin, Director of Development Programming; also attending was Chad Fleck, Deputy Director, and on video-conference from Tegucigalpa and San Jose respectively, representatives of the Canadian Embassy to Honduras, Costa Rica and Nicaragua – Isabelle Solon-Helal, Kyle Sundstrom, and Betrand-Xavier Asselin.

We assumed we were meeting face to face with representatives from your office as well, who were directly involved in this case and remotely with representatives from the offices of the Canadian Embassy to Honduras. Instead we were met by representatives from Development Programming for Central America, the Caribbean, and Haiti.

I am writing to you to express my strong opposition to the manner in which the GAC representative, Ioanna Sahas Martin, led this meeting, particularly how her approach made us feel that she dismisses our severe family situation involving Edwin Espinal. This meeting was a very unsatisfactory one, for she seemed indifferent to the human rights violations that we raised regarding the political prisoners, specifically my family member, and the fact that human rights workers and the Honduran people are not afforded the right to due legal process, the rule of law and the right of free speech.

Ms. Martin tended to dismiss the work that our very supportive community of Elmvale has accomplished in raising awareness of these human rights abuses and seemed condescending in her tone as to the role that rural agricultural communities play in addressing issues that directly involve the Canadian government.

As the Government of Canada specifically supplies annual fiscal aid to Honduras, our rural community is in opposition to Canadian aid going to Honduras as long as the Honduran government violates human rights.

Despite Ms. Martin's defense of how Canadian fiscal aid is utilized by the Honduran government it is NOT used in promoting the rights of the Honduran people to express their democratic views and is NOT ensuring that human rights are being respected. Canada is turning a blind eye to the worsening human rights conditions including widespread impunity, the lack of rule of law, and most recently the murder of over 35 Hondurans in the post electoral context.

Our rural community of Elmvale supports the work of the Simcoe County Honduras Rights Monitor, as documented by their letters to MPs and Canadian and Honduran authorities and is determined to continue to pressure the Canadian government to publicly demand of the Honduran regime of Juan Orlando Hernandez to release all political prisoners and drop all charges.

We are also demanding that the Canadian government, under your leadership through Foreign Affairs Canada, suspend all aid to Honduras until the human rights of the people are upheld. Our community continues this advocacy and will not stop until we are successful.

#### **Demands - short term**

The Canadian government must:

- Condemn endemic repression and human rights violations in Honduras, since the stolen November 26, 2017 elections, including the State killing of 40 people, the jailing of dozens of political prisoners, etc;
- Suspend economic, political and "security" relations with the Honduran regime
  until the political/electoral crisis is resolved, until systemic State repression and
  corruption have ended, until the political prisoners are released and all trumpedup charges dropped, and until proper criminal investigations have been initiated
  into all the State killings and violations since the November 26, 2017 "elections".

### **Demands - medium term**

Canada desperately needs parliamentary and senate inquiries into the causes of Honduras' now endemic repression and exploitation, corruption and impunity, with a specific focus on the role played by the Canadian government:

- in support of the 2009 military coup
- in legitimization of fraudulent and violent elections in 2009, 2013 and 2017
- in support of the (potentially illegally signed) "Free Trade Agreement" with the military-backed regime in power in Honduras
- in support of the expansion of Canadian corporate investments in Honduras (mining, garment "sweatshop" industry, bananas, hydro-electric dams, tourism, African palm, etc.),
- all while turning a blind eye to and –in effect– benefitting from repression, fraud, corruption and impunity.
