The U.S. and Canadian governments maintain a military, political and economic relations with the repressive, corrupt government of Honduras, *YET SOMEHOW* have no influence to pressure that same regime to release political prisoners arrested and detained on fraudulent charges related to protests against the violent, fraudulent elections of November 2017, and the dozens of people killed by government forces since then.

# Update from Janet Spring, Edwin Espinal's mother-in-law September 29, 2018

Dear friends, I am checking in to tell you that there is no concrete news on the political prisoner situation, except that a so-called dialogue process has started in Honduras. According to twitter, the dialogue meetings have one aspect of focus and that is to concentrate on the political prisoners and an amnesty for them. Without significant pressure from the "international community" – that in many ways props up and legitimizes the Honduran regime -, we will not be holding our breath.

We are keeping a measured hope from the dialogue process for an immediate amnesty for all political prisoners. BUT, politicians in Canada and the U.S. need to hear from us that they must pressure the State Department and Global Affairs to openly and strongly demand this of the Honduran regime. If an immediate and full amnesty does not happen we will be devastated. If the political prisoners' cases go "to trial" in Honduras' notoriously corrupted "judicial" system, there is no chance that they will receive a fair trial as most judges are part of the National Party and are appointed by the illegal President, Juan Orland Hernandez, and his predecessors.

#### Demands - short term

The U.S. and Canadian governments must:

- Do an about face and rescind their "legitimization" of the Nov. 26, 2017 elections (Good luck with this one!);
- Condemn the multiple acts of electoral fraud carried out by government of Juan Orlando Hernandez;
- Condemn government repression, including the killing of over 40 pro-democracy protesters, and the illegal detentions of dozens of political prisoners, including Edwin Espinal;
- Suspend business and military-police-security relations with the government of Honduras, until the political / electoral crisis has been resolved and impartial justice processes are proceeded against the intellectual and material authors of the electoral fraud and stolen elections, and killings and illegal jailings.

#### **Demands - medium term**

There must be legislative inquiries in the U.S. and Canada into the causes of Honduras' now endemic repression and exploitation, corruption and impunity, with specific focus on the role played by the U.S. and Canadian governments:

In support of the 2009 military coup

- In support and legitimization of fraudulent and violent elections in 2009, 2013 and 2017
- In support (in the case of Canada) of the promoting and signing of the potentially illegitimate "Free Trade Agreement" with the government of Honduras;
- In support of the expansion of corporate investments in Honduras (mining, garment "sweatshop" industry, bananas, hydro-electric dams, tourism, African palm, etc.), while turning a blind eye to and in effect benefitting from repression, fraud, corruption and impunity.
