Rivers are being poisoned and graveyards dug up, in pursuit of gold. Even the dead can't rest in the town of Azacualpa, Honduras, as Aura Minerals - a Canadian/U.S. mining company supported by the corrupt, repressive, U.S. and Canadian-backed Honduran regime – digs up bodies for gold.

Dear Aura Minerals: Please return the remains of Angela Sanabria to her family!

On December 9, 2019, the Azacualpa Environmental Committee denounced that Aura Minerals (and subsidiary MINOSA) illegally entered the Azacualpa cemetery in the wee hours of the morning, dug up and made off with the remains of Angela Sanabria, buried there 22 years before.
