With the appearance of "legality", the US & Canadian-backed Covenant of the Corrupt government continues to use the legal system as a weapon of war, increasing attacks on the elections and on the Semilla Party itself, to prevent the August 20 run-off election.

Rights Action continues our calls for Americans and Canadians to share this information widely (including media outlets), and to directly contact your Senators, Members of Congress and Parliamentarians, and urge them to make public statements and bring all pressures to bear on the Guatemalan authorities to ensure that the electoral process proceeds transparently and peacefully and that the Semilla Party is allowed to participate fully with no further attacks of any kind.
